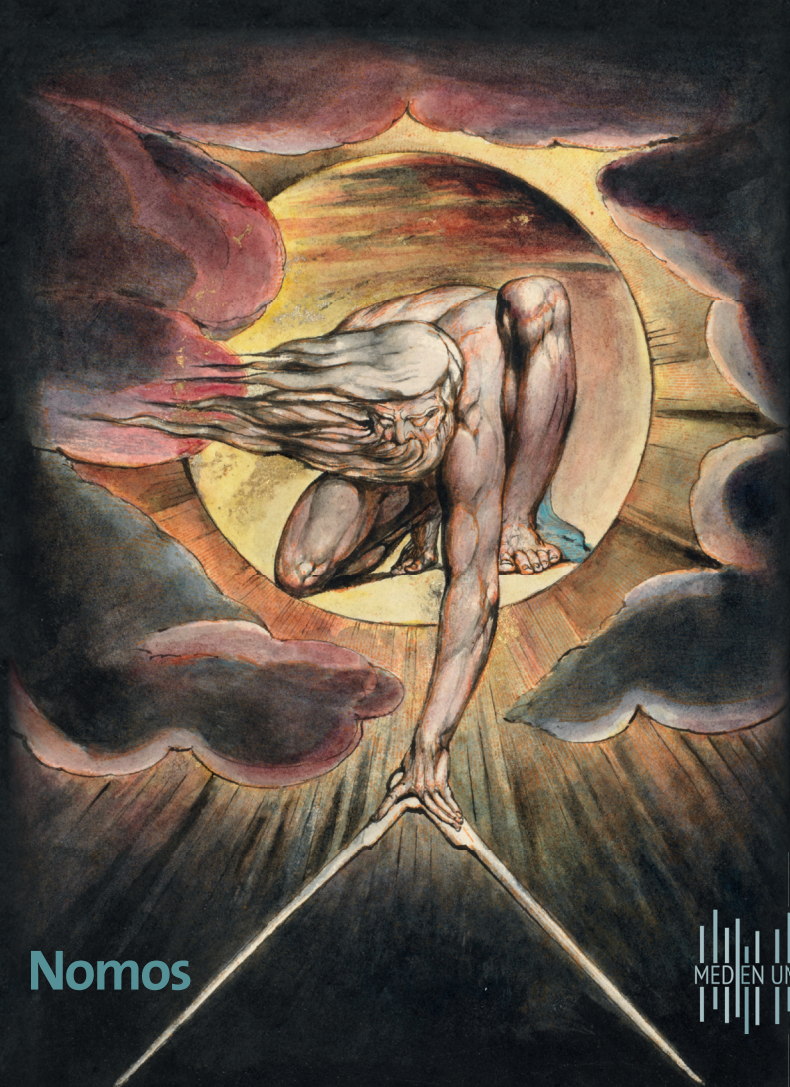

## Authors
